In the charts below: find your desired certificate, your current discipline, and consult the years of service line relevant to you.

- Must have a minimum of 10 years full-time emergency communications experience



# Higher Level Certifications at a Glance



The breakdowns of the certifications below are cut to their most basic form. Before applying, refer to IDAPA 11.11.01.073 for full qualifications. These certifications are only available to peace officers, detention deputies, and emergency communications officers.

## **Supervisor Certificate**

- Must be currently employed as a first-line supervisor for a minimum of 1 year
- Possess an intermediate or advanced certificate in your relevant discipline
- Have 100 hours of POST supervisory-level training (600+ level courses)
  - 50 of the above hours must be completed within the last 3 years immediately prior to applying

## **Master Certification**

- Must hold a rank below sergeant (supervisory experience does not qualify)
- Possess an advanced certificate in your relevant discipline
- Have 1,500 POST training hours (college hours can be converted)
- Must have a minimum of 15 years of full-time experience in your relevant discipline
  - Can not include any time held as a supervisor or above

### **Management Certification**

- Must hold a position in rank of lieutenant or higher, or equivalent title
- Must hold a POST Basic Peace Officer, Detention, or Emergency Communications certificate
- Have 100 hours of POST certified training (700+ level courses)
  - 50 of the above hours must be completed within the last 3 years immediately prior to applying
